- Immediately on dispatch of material, the LR details shall be mailed at purchase@hindlab.com
- Tax Invoice & Delivery Challan must mention: Purchase Order No., Name of Manufacturer, Drug Licence No., Batch No., Lot No., Mfg Dt. & Exp Dt., GST No., HSN Code etc.
- Material Label must mention complete Details as per the Drugs and Cosmetics Act and Regulatory requirement.
- Seller is bound to supply material as per Purchase Order. Material supply strictly as per the Quantity and Specification, Terms & Condition mentioned in Purchase Order.
